**DELAY IN DESPATCH OF CIRCULAR REGARDING  
CONTINUING CONNECTED TRANSACTIONS  
RENEWAL OF STEAM SUPPLY AGREEMENTS**

Reference is made to the announcements of China Sanjiang Fine Chemicals Company Limited (the “**Company**”) dated 1 January 2018, 23 January 2018, 29 January 2018 and 1 March 2018 regarding (i) the Renewed Steam Supply Agreement entered into between Xing Xing and Jiahua Energy Chemical Co and (ii) the Renewed Supply Agreements entered into between each of Sanjiang Chemical and Sanjiang New Material with Jiahua Energy Chemical Co (collectively, the “**Announcements**”). Unless the context otherwise requires, terms defined in this announcement shall have the same meanings given to them in the Announcements.

The Company has indicated in the Announcements that a circular containing, among other things, (i) further information on the Renewed Steam Supply Agreement, the Renewed Supply Agreements and the respective proposed annual caps contemplated thereunder, (ii) the recommendation from the independent board committee to the independent shareholders, (iii) the advice from the independent financial adviser to the independent board committee and the independent shareholders; and (iv) a notice of the EGM, will be despatched to the Shareholders on or before 31 March 2018. As additional time is required for the Company to finalise certain information in relation to the

Renewed Steam Supply Agreement and the Renewed Supply Agreements, and (ii) the Company wishes to combine the circular of the Renewed Steam Supply Agreement with that of the Renewed Supply Agreements so that only one EGM notice will be issued and one EGM will be convened, the date of despatch of the circular for the Renewed Steam Supply Agreement and the Renewed Supply Agreements will be postponed to a date falling on or before 19 April 2018, which is the same date as the planned publication date of the circular and notice of the Company convening the annual general meeting of the Company to be held on 21 May 2018 for the purpose of avoiding any misunderstanding and confusion.
